This report will be due within 12 months from receiving this award.
3. If awarded funds are not expended within one year, the award will be cancelled unless specifically extended by the Goodcents Board of Trustees. Unused funds are to be returned to the Goodcents program.

The Board of Trustees makes donations from funds collected through the Goodcents Program. These funds are voluntary contributions from participating GVEA members. By signing, you give permission to have information about your project reported to the membership of GVEA.
