**AGREEMENT**

**AUTOMATIC CONTINUANCE OF ELECTRIC SERVICE BETWEEN TENANTS**

This agreement is made between Golden Valley Electric Association, Inc., hereinafter called the “Association,” and

**WITNESSETH:** The Association will provide electric service in the Owner’s name during periods of vacancy between tenants at the following service locations:

**THE OWNER AGREES TO:**

- 1. Pay for electric service provided to the stated locations during those periods when no tenant has opened an account in the tenant’s name or, if there was an account in a tenant’s name, electric service to that tenant has been terminated upon request by the tenant.
- 2. Inform all tenants at the above locations that they are required to open an account with the Association immediately upon occupancy.

**THE ASSOCIATION MAY DISCONTINUE ELECTRIC SERVICE:**

- 1. If the tenant is delinquent in the payment of billings for electric service at a location covered by this agreement and the Association has complied with the notice requirements imposed by regulations of the Regulatory Commission of Alaska, or
- 2. If the Owner is delinquent in the payment of billings for electric service at a location covered by this agreement and the account is held in the Owner’s name, and the Association has given the notice required by regulations of the Regulatory Commission of Alaska.

**THE AGREEMENT MAY BE CANCELLED IF:**

- 1. Service has not been transferred into the tenant’s name after the Association has given reasonable and adequate notice to the Owner, or
- 2. The Owner is delinquent in the payment of billings for electric service at any location covered by this agreement, or
- 3. The original or a conformed copy of a recorded deed is submitted by another person to the Association as proof of ownership of the property described in this agreement, or
- 4. The Association receives a written request for cancellation from the Owner, or
- 5. The Association gives a 10-day written notice to the Owner. Notice shall be considered as given when mailed by the Association to the Owner at the address shown in the membership records.

Upon cancellation, deposits shall be applied to debts due the Association from the Owner. This agreement shall become effective when signed by the Association.
