**RULES AND REGULATIONS**

**Rule 10. Special Services**

For special services that are performed by the Association (other than normal work associated with supplying Electric Service), a Member will be charged the actual cost incurred by the Association in providing such special services including, but not limited to labor, transportation, materials, indirect costs, and applicable overhead. Examples of special services include, but are not limited to the following:

1. Installation of Temporary Electric Service.
2. Relocation or removal of Association-owned or jointly-owned poles, wires, or other facilities.
3. Making changes to Association facilities to accommodate a Member's wishes in addition to those services set forth in Rate Schedule M - Schedule of Deposits, Charges and Fees or as otherwise provided for in this Tariff.
4. Troubleshooting and/or making emergency repairs to a Member's electrical equipment or repairing Association equipment damaged by a Member (including a Member's family member, guest, or invitee) or a Member's contractor or agent.
5. Upgrading the Association's facilities to accommodate additions or changes in a Member's load.


